Barriers to youth participation continue to mount



outh in Zvishavane lamented their exclusion in political processes noting that the political spaces in Zimbabwe have not been friendly towards youth efforts for political and civic empowerment.

During a Youth Civil Rights forum hosted in the mining town by Hands of Hope Trust, youth said platforms for youth to meaningfully participate continue to shrink as greater representation of youth is perceived as a threat by those in positions of power.

This in turn has made youth avoid participation in politics and related activities.

"It's no secret that the elders who are in power don't want to give up that power especially to us young people. When we try to stand up to contribute to development discourse they say we are getting

too big for our shoes, that we are being rebellious.

"Our rights are threatened more often than not, by being denied platforms to participate, our voices being silenced due to threats of physical harm by state agents and discrimination based on age and gender," said Manasseh Chikutirwa.

The the aim of civil rights competition was to energize the youth in Zvishavane to not only develop interest in civil rights education but also promote a culture of meaningful political participation while addressing poor access to information, one of the barriers to youth many participation.

"There are a lot of hindrances and uncertainties as to why youths should participate in political processes. Our aim is to empower the youths in Zvishavane with information, to motivate them to participate in political processes by registering to vote, casting ballots and stand political even as candidates in the upcoming 2023 election.

"It's vital to educate youths on their civil rights, to know why it is important to participate in civic processes to know their constitutional rights so that they make informed decision especially on issues that affect them," said Millicent Nhutsve, Director of Hands of Hope Trust.

Lack of information, exclusion and discrimination, lack of faith in elections, economic instability, and lack of support were cited as some of the high-level barriers that hinder active participation by young people.

"Many of us young people have lost faith in the elections, we would rather not vote at all than feel as if our votes are stolen every election. We would rather focus on hustling to rather survive than listen to politicians give US empty no promises or waste time campaigning for a political post when I know no one will take me seriously because I don't have the resources to run a successful campaign against an old man who has been in the game for many years," Tatenda Gwezuva lamented.

To advance youth engagement, it is crucial that young people are perceived as partners to national development through capacity building, promoting safe and enabling environment for young people's participation and implementation of their ideas.

Disability is not inability!!!

he Nkomwa Foundation Trust (NFT) is a disability led Community Based Organisation operating based in Matabeleland South Province in Zimbabwe. The organization was founded in 2018 and formerly registered as a Trust in October 2020 with the aim of promoting the rights of Persons with Disabilities at the time contribute same towards communities creating that embrace persons with disability as equal human beings.



The organization has gone a step further by trying to improve engagement between Persons with Disability (PWDs) and policy makers in a bid to influence development of inclusive policies and provision of services that responds to their needs. This is being done through town hall meetings between local authorities and the community of disabled persons across Gwanda, Matobo, UMzingwane and Beitbridge. Speaking to the Director for NFT, Pick Nkomwa, he had this to say:

"Our mission is to uplift and support Persons with Disabilities (PWDs), promoting their rights, and helping them achieve their aims for selfsufficiency and sustainability in the future while our vision is to create a conducive environment, inclusive society and built on trust, respect equality, where solid foundation for persons with disabilities is laid to ensure they live a life they choose," Nkomwa said.

The Foundation's main programming focuses on advancing the rights of persons with disabilities in Matabeleland South province and beyond. Since inception, the organization has maximize managed to in partnerships and collaboration to

visibility maintain the of the organization at the same time promote public education on the rights of persons with disabilities. It has managed to conduct a number of educational forums so as to challenge discrimination against persons with disability through advocacy and awareness raising. At one time, the organization managed to engage Zimbabwe Lawyers for Human Rights represent one of its members who was subjected to sexual assault but failing to meet justice due to failure by Police to conduct investigations. After the engagement of lawyers, the person managed to get justice and the perpetrator is now remanded in custody waiting for finalization of the case. All this points out to the commitment of the organization in fighting for the rights of persons with disability.

The organization has also managed to source utilities, clothes and hygiene packs which were distributed to 80 persons with disability in Gwanda, Matobo and Beitbridge during the Delta COVID

19 variant. It has also sourced and distributed 20 assistive devices such as wheelchairs and clutches to members who are in need of these devices.

"To maximize on raising awareness public education and on preventative measures and precautions in the light of COVID 19, the organization managed to share electronic brochures to beneficiaries which went viral the reach of increasing organization. In a bid to increase self-reliance of the target group, the organization managed capacitate a total of 25 persons of disability on detergents making through vocational training. To this date we have 3 persons with disability benefiting from our economic empowerment desk, through accessing small start-up funds," added Nkomwa.

Realising the importance of education even amongst people with disabilities, The Nkomwa Foundation Trust has managed to assist beneficiaries with school needs at primary and secondary

level. Also, training on economic empowerment was

It has also managed to assist 7 beneficiaries with school needs in Secondary level and 5 beneficiaries Primary level. Training Economic empowerment were done in collaboration with Bible Society of Zimbabwe. All this feeds into the organizational thematic that include economic areas educational empowerment, support, welfare and care.

The organization, has become a safe space for persons living with disabilities, in that whenever they face challenges, they are able to go to the organization for psychosocial support and representation. NFT is now regarded as a strategic stakeholder by local authorities, social services department and women affairs ministry on issues around inclusivity promotion and planning. As such, the organization has been participating in national and regional level research papers seeking to ascertain the needs of the persons with disabilities, a situation that further confirms the

impact made thereof leading to recognition of our work.

line of work NFT has collaborated with many likeminded organisation they advance different needs and issues of people with disabilities. NFT has also collaborated with Disability Resource and Advocacy on research on caregivers of differently-abled children, a process that assisted us to consider coming up with child friendly policies targeting those with disabilities. Another collaboration between Zimbabwe Red-cross in celebrating International Women's Day mainstreaming the rights of women with disability as a way of promoting their inclusion participation. In December 2021, they also collaborated with Matobo Youth Development Initiative in Malaba Village where community educated members on the rights of persons with disabilities. Again in December 2021 facilitated with a meetina Community Youth Development

Trust in Gwanda, where they educated youths on their role to safeguard rights of fellow youths with disability at community level. This was done on the International Human Rights Day. Also worked with Souls Comfort Trust in raising awareness on disability rights in Gwanda rural as a way of changing community and leader's mind-set, practice and attitudes on people with disability.

"We are quite grateful for the collaborations that we have done with other organisation so far. We currently have an ongoing program with Isango Elihle, an organisation based in South Africa that promotes economic empowerment of youths with Albinism. Again, during the first week we partnered with ALASO Academy and Sunrise sign language academy to train stakeholders and our members on sign language as a way promoting improved interaction and communication with the deaf community," Nkomwa added.

Call for legal framework that enable effective youth participation

Realizing that youths are a positive force to transformative social change and economic development, there is need for stakeholders to come together and push for effective legal framework that support their sustainable participation and engagement at local levels. The national developments that have seen the finalization and signing of the 3rd Youth Policy are recognized as a positive step towards youth empowerment thus if such policies are fully implemented.

It is worth noting that the calls for youth empowerment have been ongoing for decades and it is high time such processes are devolved to local levels where the majority of the young people are located. Participation is a central component of good governance which is a key ingredient in social and economic development. As a youth concerned organisation, it is our call that local government institutions at the aforementioned levels should localize the National Youth Policy and promote a culture of youth participation in local decision-making spaces.

Lack of youth participation in critical sectors limit their development and influence in pushing for youth friendly services and policies. It is worrisome that relegation of youth to the periphery of decision making continues despite the energy and commitment displayed by the youths to be more engaged in public life for them to be authors of decisions relating to their socio political and economic needs. Notable, there is mutual feeling among the youths across the province on the need for a comprehensive legal framework that promote institutionalization of youth participation and engagement so as to remove that political tag that is always associated with advocacy. At the same time, young people are of the opinion that their inclusion in formal decision-making spaces from local to national level is important and feeds into the 2030 agenda for sustainable development.

This calls for an effective implementation plan of the youth quota provided for in the 3rd National Youth Policy. The plan should be made public for accountability purposes and easy to follow up. CYDT also calls upon the government to consider amending the constitution such that it provides for the youth quota so that youth participation in public spaces and decision making becomes a constitutional matter. We also call upon for unified efforts in creating safe spaces for youth effective participation.

Breaking Free From stereotypes:

Young women forums boost their political interest…lobby for young women quota.

"Young women want to drive their own destiny."

e hear this all the time but the sentiments were most definitely felt during the young women political forums organised by Community Youth Development Trust in Matobo, Bulilima, Gwanda and Beitbridge.

The forums sought to promote sectorial capacity strengthening and was quite instrumental in empowering young women to rise above the existing structural and traditional barriers that continue to militate. The forums were premised on constitutional rights and sections. They also served as a platform to inter-generational close gaps between older and younger women within the political arena.



Women in Matabeleland South are painted as abiect, nurturers. emotional and begrers of culture. Societal myths and tradition suggest and enforce that decision-making, politics, and leadership are not suitable for young women. Womanhood is often associated with being timid, reticent and diffident, which differs from the characteristics expected of politician, which are ascribed by same society, as assertive and confident. Speaking on the side lines of the forum in Bulilima, Ntando Sibanda had this to say.

"I am really grateful for these forums because they bring out the best of me. Activities I attend with my male counterparts are quite different in that they always want to dominate the space, however, these forums that were specific for us young women made us come out of our shells and speak from the heart," Sibanda said.

Participants across the project areas felt that the forums helped boost their confidence as well as foster solidarity among women. They gave them common voice to address the structural and cultural barriers underpinning young women's political participation and leadership.

"Being able to share experiences in a safe and open environment identify helped common challenges. The forum bolstered my leadership skills and also afforded opportunity me the to forge relationships with established women political leaders. All I can

say is that my confidence is on another level, if other women have done it, why can't I," asked Sinothando Mathonsi.

It is also during these forums where young women have called upon powers that be to increase young women's representation in politics. The young women identified 3 priority areas namely; nurturing young women's political aspirations, supporting young women candidates for political office and empowering young women in office, investing in their future. They are also calling for a young women's quota as the current women's quota does not have clear provisions on how to include young women, does not extend to local government. Therefore, this means that young women shall always be in the of decision periphery making because even on the 10 seats for the youths, nothing is specific on young women.
